

<p><b>COVERAGE may include:</b></p> <p><b>Preventive Counseling</b>                      99385-99387, 99395-99397</p> <ul style="list-style-type: none"> <li>- NC Medicaid covers one adult preventive medicine health assessment per year, to include:</li> <li>- a comprehensive physical examination</li> <li>- a comprehensive health history</li> <li>- anticipatory guidance/risk-factor reduction interventions</li> <li>- ordering of appropriate diagnostic procedures</li> </ul> <p><b>Behavioral Assessment/Intervention</b>                      96150-96151</p> <p><b>Nutritional Consultation &amp; Therapy</b>                      97802-97803</p> <p><i>NOTE: Additional services may be available to members enrolled in <b>CCNC/Carolina Access</b>, the state's primary-care case management program.</i></p> <p><i>NOTE: Dietary evaluation and counseling services are covered only for children through 20 years of age and pregnant/postpartum women with medical necessity. (<b>Clinical Coverage Policy No. 1-I</b>)</i></p>	<p><b>NOT COVERED</b></p> <p>NC Medicaid explicitly <u>excludes</u> coverage for weight loss and weight gain drugs.</p>
