|  | <p><b>Bariatric Surgery</b></p>   |   |
|  | <p><b>COVERAGE may include:</b></p> <p>Gastric Bypass, Gastric Band, Sleeve Gastrectomy</p> <ul style="list-style-type: none"> <li>- <b>Prior authorization</b> is required.</li> <li>- Bariatric surgery for obesity is covered for individuals 18 years and older with a BMI <math>\geq 35</math> with type II diabetes or another significant comorbidity (BMI <math>&gt; 40</math> without comorbidity).</li> <li>- The individual must have no prior history of bariatric surgery, unless in failure due to complications of the original surgery.</li> <li>- The individual must participate in pre- and post-surgical psychological, medical, surgical, and dietician evaluations.</li> </ul> <p><i><b>NOTE:</b> All approved surgical programs must submit outcomes data to DMAP.</i></p> |   |
